- 39 Vendors are required to give a Demand Draft / Pay Order / Bank Guarantee (of Nationalised Scheduled Bank) drawn in favour of "Principal, Police Training School, Mawroh, Shillong - 8", payable at any branch of any scheduled or nationalized bank and valid for 3 months from the due date of the tender opening for the calculated amount as Earnest Money Deposit (EMD) along with their offer.
- The earnest money deposit shall be non-interest bearing and is refundable to unsuccessful bidders. The successful bidder's EMD will be discharged upon the successful bidder executing the contract and furnishing the Security Deposit of 10 % of the order.
