NOTIFICATION

The 12th May, 2025.

No.ERTS(T) 81/2014/Pt/77. - In exercise of the powers conferred by Section 40 of the Meghalaya (Sales of Petroleum products including Motor Spirit) Taxation Act, (Assam Act IX of 1956) as adapted and amended by Meghalaya, the State Government hereby notifies restrictions on transport of Motor Spirit (MS) and High Speed Diesel (HSD) from outside the state to a maximum of 200 (two hundred) litres by any person other than those registered under Section 6 of the Act. Further, the State Government hereby **exempts armed forces and para-military forces and vehicles transporting petroleum products on transit but not for use in Meghalaya from any such restrictions.**

This notification shall come into force at once and until further orders.
